In accordance with [Texas Education Code \(TEC\) §31.1011](#) local school systems are required to annually certify to the State Board of Education (SBOE) and TEA commissioner that students have access to instructional materials covering all Texas Essential Knowledge and Skills (TEKS) for all required subjects, except physical education.

Certification 2026–27 Survey submissions received after May 15, 2026, are typically processed within five business days of receipt, and access to allotment funds in EMAT will follow.

With the growth of our CTE (Career and Technical Education) and PTECH (Pathways in Technology Early College High School) programs, an additional counselor has become necessary to strengthen student support and program outcomes. Currently Mr. Sal Acosta, the ECHS counselor, is responsible for up to 300 ECHS students in addition to a growing P-TECH program with over 100 students, that will soon include an incoming freshman class of 40 students, creating a workload that limits the level of individualized guidance students needed to be successful.

A PTECH/CTE-focused counselor would provide targeted academic and career advising for high-need CTE and Dual Credit students, expand coordination of industry-based learning opportunities such as internships and certifications, and ensure stronger alignment between coursework and workforce pathways. Additionally, this role would provide critical support for special education students by actively participating in ARD meetings and helping tailor transition plans that connect students to viable postsecondary and career options. Overall, this position would enhance student achievement, improve program quality, and better position the district to meet CCMR goals.
